The net profit (before balancing the corporate tax) recorded 162 trillion won in 2018, which fell by 6.4% from 173 trillion won in 2017.
The net profit (before balancing the corporate tax) per 1,000 won of annual sales recorded 66.0 won in 2018, dropping by 7.9 won from 73.9 won in 2017.
□ Among survey target enterprises, 5,684 enterprises operated subsidiaries. Among them, 3,214 enterprises operated overseas subsidiaries, which increased by 4.1% from 3,088 enterprises in 2017.
Overseas subsidiaries were mainly located in China (29.9%), the United States (12.7%) and Vietnam (10.9%).
☐ The research and development expenditures (excluding 'Financial and Insurance
Activities') amounted to 54.7 trillion won in 2018, which increased by 11.8% from 49.0 trillion won in 2017.
