


2021 Newlyweds Statistics

1. Overview of newlyweds

- □ In 2021, the newlyweds totaled 1.101 million couples, dropping by 7.0% (82 thousand couples) from 2020.
- O The newlyweds in the first year of marriage dropped by 10.4% from 2020.





2. Child and chid care of couples at first marriage

□ (Child)

The share of newlyweds at first marriage with a child stood at 54.2%, down 1.3%p from 2020. The average number of children of newlyweds at first marriage stood at 0.66 person, falling by 0.02 person from 2020.

- O As for the share of newlyweds with a child, dual income newlyweds stood at 49.6%, which was 10.9%p lower than single income newlyweds (60.5%).
- O As for the share of newlyweds with a child, couples of economically active wives stood at 49.1%, which was 13.0%p lower than those of economically inactive wives (62.1%).
- O As for the share of newlyweds with a child, couples not owing a housing unit stood at 50.1%, which was 9.8%p lower than those owning a housing unit (59.9%).

□ (Child care)

As for child care of newlyweds at first marriage, 'Day care center' occupied the largest share at 50.0%, which was followed by 'Home care' (44.2%) and 'Kindergarten' (3.4%).

 O Among dual income couples, 'Day care center' occupied the highest share at 53.8%. Among single income couples, 'Home care' occupied the highest share at 47.8%.

3. Economic activity of couples at first marriage

\Box (Dual income couple)

The dual income couples occupied 54.9% of the total newlyweds, rising by 2.9%p from 2020.

□ (Income)


The annual average income of newlyweds marked 64.00 million won, rising by 6.9% from 2020.

- Newlyweds earning '50 million ~ less than 70 million won' occupied the largest share at 22.4%, which was followed by '30 million ~ less than 50 million won' (22.0%) and '70 million ~ 100 million won' (20.2%).
- O The annual average income of dual income newlyweds (80.40 million won) was 1.7 times higher than that of single income ones (48.11 million won). The annual average income of newlyweds owning a housing unit (72.35 million won) was 1.2 times higher than that of newlyweds not owning a housing unit (57.97 million won).

(Loan)

Newlyweds with loans from financial institutions occupied 89.1% of the total newlyweds, up 1.6%p from 2020.

O The median value of loans from financial institutions stood at 153.00 million won, which grew by 15.4% from 132.58 million won in 2020.



4. Housing status of couples at first marriage


□ (Type of living quarters)

The largest share of newlyweds (72.1%) resided in apartments, up 0.4%p from 2020.


□ (House ownership)

42.0% of newlyweds owned a housing unit, which decreased by 0.1%p from 2020.

O 30.7% of newlyweds in the first year of marriage owned a housing unit. 51.9% of newlyweds in the fifth year of marriage owned a housing unit. The longer marriage period, the higher share of newlyweds owning a housing unit.
